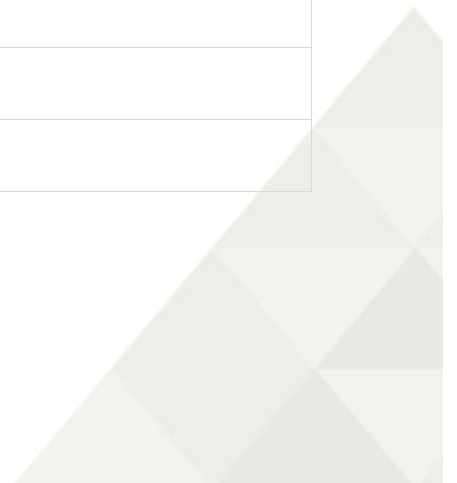

It is anticipated that meetings will predominantly take place in Oakey, however some may take place in alternative locations. Please tick the box below to acknowledge that you are available to travel.

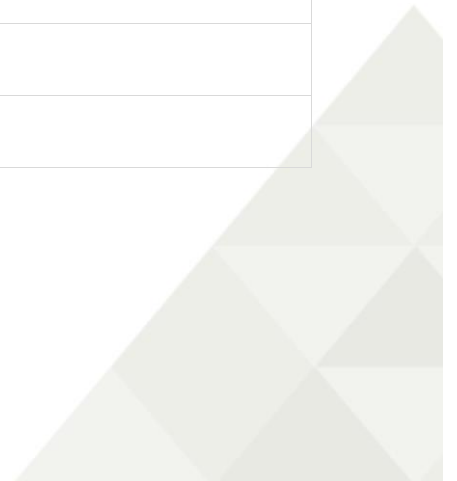
